

HEERF III – American Rescue Plan Funding General Report 11/10/2021

The Higher Education Emergency Relief Fund III (HEERF III) is authorized by the American Rescue Plan (ARP), Public Law 117-2, signed into law on March 11, 2021, providing \$39.6 billion in support to institutions of higher education to serve students and ensure learning continues during the COVID-19 pandemic.

ARP funds are in addition to funds authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law 116-260 and the Coronavirus Aid, Recovery, and Economic Security (CARES) Act, Public Law 116-136. Emergency funds available to institutions and their students under all emergency funds total \$76.2 billion.

The institution has signed and returned to the Department the Certification and Agreement. Thaddeus Stevens College of Technology will use the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.

This report provides details on the emergency funds that Thaddeus Stevens College of Technology (TSCT) received under the HEERF III - ARP.

- TSCT has received a total of \$4,807,007 in HEERF III funding. The minimum amount for Student Aid Portion (CFDA 84.425E Allocation) is \$2,403,504. The maximum amount for Institutional Portion (CFDA 84.425F Allocation) is \$2,403,503.
- The ARP funds were received as of 06/10/2021.
- On 08/05/2021, 1263 students were mailed postcards that encouraged students to reach out to the Financial Aid Office if they have had a reduction in income since 2019. Additional postcards will be mailed out as new students are offered for spring 2022 admissions.
- Funds were drawn down in the amount of \$2,380,699 on 11/01/2021.
- 1199 paper checks were distributed to students in the amount of \$2,380,699 on 11/09/2021.

Thaddeus Stevens College of Technology received Federal funds through the American Rescue Plan (ARP) to assist students with expenses incurred as a result of COVID-19. A portion of these funds will go directly to students.

The College has decided to allocate 55% of the student portion of the funds to students who are Pell Grant recipients and the remaining 45% of the student portion of the funds to Non-Pell Grant recipients.

- Resident students will receive their checks in their dorms, and all commuter students will be mailed their checks.
- Distribution of Funds 55% of total allocation will be Pell Grant Students, and 45% of total allocation will be Non-Pell Grant Students

Eligibility

- All students on the Officially Enrolled Census Report for Fall 2021 are eligible to receive the funds disbursed on 11/09/2021. Students eligible to receive the Federal Pell Grant as of 10/12/2021 will receive 55% of the total allocation, and students who were non-Pell Grant eligible as of 10/12/2021 will receive 45% of the total allocation.
- The college has determined that all students have expenses related to the disruption of campus operations due to the Coronavirus.
